



KEY SUCCESS FACTORS

Excellent location

Located in north-west Ukraine, Rivne region is well positioned to serve the markets of European Union, Russia, Belarus and Ukraine.

Rivne is situated at the crossroads of international motorways and railways connecting Europe with Asia, and the Baltic Sea with Black Sea. The distance to the EU border is just 100 km (1,5 hours drive), and 320 km (3 hours) to Kyiv, the capital of Ukraine.

In addition, Rivne region enjoys a developed railway system. The operational length of railway lines of general use is 587 km.








3. Dynamic and growing economy

Positive macroeconomic indicators and a strong growth in demand make the Ukrainian market an attractive choice for investors, and the Rivne region is the perfect place for entering the market. Regional industry growth rates are markedly higher than the national average (+8.9% in 2006).

Wood-processing

Wood-processing in Rivne region plays an important role and demonstrates an accelerated development. Based on the availability of raw materials and high qualification of labor force, the wood-processing industry is prepared to compete successfully with other furniture industries in Europe and Asia.

Construction materials and Glassware

The enterprises of glassware and construction materials sectors constantly modernize and increase their production capacities. The dynamic growth of the food industry contributes to the stable development of the glassware industry. Considerable deposits of high quality and low cost raw materials as well as highly skilled and effective labor force make building materials production a very attractive sector for investment.





Food industry

Stabile development of food industry is supported by the local agricultural production. Constantly growing demand in the domestic market as well as export opportunities spur the growth of the production volumes. It is expected that the domestic market will continue to develop quickly, and the growing income of population will increase the demand for high quality food products.

Machine building

The machine-building sector of Rivne region is represented by enterprises, which produce equipment for agricultural machines. During the last years the sector is developing quite dynamically due to increased export and steadily growing domestic demand. The industry enjoys the locally available skilled and experienced labor force. Considerable production capacities, which are not being used, and profitable enterprises striving to extend their capacities can give investors additional advantage.

Natural Resources

The extraction of energy and non-energy materials in Rivne region might be a future business area for foreign investors because of the

considerable volume of high quality natural resources. More than 600 deposits of 18 types of minerals are located in region. Among these deposits is the only deposit of amber in Ukraine as well as unique beds of basalt. The reserves of peat amount to 18% of all deposits in Ukraine. Rapid growth in industrial and private construction as well as road building will serve as the main reasons for growth in this sector.

Education


Rivne region holds a wealth of local talent. Workers are highly qualified, productive and driven to develop their professional skills. Each year more than 5000 students graduate from Rivne region's 33 universities and institutions of higher and professional education.

Universities and businesses in the region have a long history of cooperative relationship. It ensures the competitive advantage of the local workforce.

Labor costs

Wages and all other payments in Ukraine have to be paid in Ukrainian hryvna (UAH). As of 01.01.2007 the average monthly gross salary in Ukraine amounted to 1277 UAH (or 253 USD), in Rivne region 1124 UAH (or 222 USD).

In Rivne region, the official registered unemployment rate amounts to 4.7% as of 01.01.2007.

RICH CULTURE AND HISTORY

Rivne region is widely known for its hospitality and its versatile and rich cultural life. Festivals, art events and concerts are regular features for the region, and its large number of restaurants, coffee shops and clubs provide plenty of choice for places to relax and socialize.

The area boasts considerable recreational possibilities. The region is home to two historical and cultural state reserves in the form of the ancient towns of Dubno and Ostroh, whose 15th and 16th-century architecture and landmarks provide a glimpse of the region's history.

The region is also home to three historical museums and seven of local lore. Unique landscapes, wildlife preserves, basalt columns, amber deposits and activities such as hunting, and rafting are just a few of the amazing attractions that the region has to offer.
